## 3rd Open International Championship among Professional Club Teams in 64- Russian and International Draughts

### 'Draughts League – 2024'

### 'Bratislava Open – 2024' stage 2 (individual tournament)

### Regulations

#### I. GOALS AND OBJECTIVES

- 1.1. The aim of the competition is to develop and create an attractive image of draughts sports in Europe and in the world, as well as to create a competitive environment for athletes from different countries.
- 1.2. To develop draughts as professional sports in Europe and in other world draughts regions.
- 1.3. To identify the best professional club team.
- 1.4. To support talented draughts players by creating a professional environment to ensure high results.
- 1.5. To advertise draughts in Europe and in the participating countries of the professional League.

#### II. TIME AND PLACE

- 2.1. The competition is held from August, 15, 2024, to August, 18, 2024.
- 2.2. The 2<sup>nd</sup> stage of individual tournaments with team competition will be held in Bratislava (Slovakia).

#### III. ORGANIZATION AND PLACEMENT

- 3.1. All participants of the competition are provided with accommodation at the tournament venue.
- 3.2. Accommodation is provided in the 4-star 'Radisson Hotel' in double rooms with breakfast. The cost of one night in a double room per person per night is 65 euros.
- 3.3. Accommodation is guaranteed only for those participants who timely, before August 1, 2024, will pay for their accommodation by transfer to the account of 'Diagonāle' society. In other cases accommodation and participation in the tournament are not guaranteed.
- 3.4. The competition is organized by 'Diagonale' society and Vsevolod Teterin.

## IV. PARTICIPANTS

- 4.1. In the 'Draughts League – 2024' competition at the 2<sup>nd</sup> stage 'Bratislava Open -2024' in individual tournaments with team standings can take part draughts players of any age and gender, approved by the organizers of the competition to participate.
- 4.2. Each participant of the competition is personally responsible for his health or his parents or accompanying persons are responsible for his health.

## V. COMPETITION PROGRAM AND RULES

- 5.1. The competition at the 2<sup>nd</sup> stage is held according to the rules of FMJD and IDF, and to the principles of Swiss system in 7-9 rounds.
- 5.2. Time control:  
25 min. + 3 sec. per move (for each micro-match game) in Russian draughts;  
1 h + 1 min. per move for one game in international draughts.
- 5.3. In Russian draughts tournament is held with a draw of moves of IDF (780 positions).
- 5.4. The competition is held using Draughts Arbiter program. For a win a player gets 2 points, for a draw – 1 point, for a loss – 0 points.
- 5.5. The winner is the participant who scores the most points.
- 5.6. Determination of places in case of equal total score:
  - 5.6.1. Solkoff system (S-1, S-2);
  - 5.6.2. number of wins;
  - 5.6.3. result of the direct encounter;
  - 5.6.4. player's rating.
- 5.7. After individual tournaments team points are calculated for the participants of 'DRAUGHTS LEAGUE – 2024'. The total team points for each team are calculated according to the following criteria:
  - 5.7.1. The sum of the places of two participants from one team in international draughts.
  - 5.7.2. The sum of the places of two participants from one team in Russian draughts.
  - 5.7.3. The best place taken by one girl (woman) in international draughts.

## VI. AWARDS

- 6.1. Based on the results of individual tournaments, the participants who take the first three places in the overall standings in both Russian draughts and international draughts are awarded the following prizes:
  - 1<sup>st</sup> place – Special Cup 'Bratislava Open -2024' + guaranteed prize money **500** EUR;
  - 2<sup>nd</sup> place – prize money **200** EUR;
  - 3<sup>rd</sup> place – prize money **150** EUR.

## VII. COMPETITION EXPENSES AND PARTICIPATION FEES

- 7.1. Competition organisational expenses are covered by the players.
- 7.2. Tournament fee is **35 euros** per each player for each tournament.
- 7.3. Three grandmasters are received at the expense of the tournament organizers (two in international draughts and one in Russian draughts) upon prior application and agreement with them.
- 7.4. **The tournament fee and payment for accommodation are accepted only by transfer to the account of the organization:**

- 7.3. Members of the 'Albatross-350' club pay a ½ part of the tournament fee.
- 7.4. All expenses related to participation in competitions are the responsibility of sending organizations.

## VIII. APPLICATIONS AND LEGAL ISSUES

- 8.1. Applications for participation are submitted by organizations (federations, clubs, body corporates) or coaches.
- 8.2. Participation in the competition must be confirmed **30 days before the specified date of the stage** by registering in the **DAMBA** electronic database and receiving confirmation from the organizers of the tournament. In the application it is necessary to specify the name, surname, year of birth of the participant and the name of the region.
- 8.3. The organizers of the tournament ensure the protection of personal data of individuals in accordance with the Legislative Acts of EU.
- 8.4. The organizers of the tournament provide video broadcasts from each stage of the competition.
- 8.5. Club may be refused an application, according to Regulation of the European Parliament of April 27, 2016 (ES) 2016/679 «On the protection of natural persons with regard to the processing of personal data and on the free movement of such data», if a minor participant of the competition or his official representatives, including guardians, do not agree with the processing of the participant's personal results, as well as photographing and videotaping for the purpose of publishing information in the mass media. Also an application may be refused in case of violation by a participant of ethical, sports and other norms of behavior at sports competitions of 'Diagonale' society system, as a result of which the course of competitions or other events of 'Diagonale' society is disrupted.
- 8.6. The participants of the tournament are familiar with and agree with the Legal and Sports Regulations of 'Diagonale' society, on the basis of which any issues arising at the competition are considered.
